Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it under NCH Act, 2020. Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy.

- 2. Accordingly, it is to inform that Part-1 proforma and all the relevant documents submitted by your college were examined as per the existing regulations. Physical inspection was carried out on 19/10/2022 and opportunity of being heard was given to the college on 15/11/2022 after finding some shortfalls during inspection The deficiencies found after hearing are as follows:
  - a. College has not submitted the OPD/IPD manual register with the Part-1 information for cross verification of the record.
  - The college is directed to furnish the details of teachers with qualification, subject, date of
    joining, total experience in current post, Mobile no and Adhaar card number for information
    and necessary action
  - c. As per the documents form- 16 is given for 69 staff members. Form 16 is not from TRACES Portal; opinion cannot be given on genuineness of the Form 16. College needs to provide the explanation regarding thisthat shall be submitted with the compliance within 30 days of issue of this letter
- 3. After considering the provisions of NCH Act, 2020 and its relevant regulations, Conditional Permission is granted to J.R. Kissan Homoeopathic Medical College and Hospital, Old Sunderpur Road, Near Jind Bye Pass Chowk, Near Gas Godown, Singhpurakhurd, Rohtak, Haryana-124001 for conducting UG (BHMS) course with intake capacity of 50 seats, for the academic session 2022-2023.
- 4. As per provisions of section 43 of the NCH Act, 2020 Central Govt has taken a policy decision vide letter no F.NO Y-11011/4/2022-EP-III Dated 14/10/2022 that all admissions shall be through NEET only with qualifying marks of 50 percentile. All admissions in Under Graduate and

Post graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under

- 6. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
